Dominion's Atlantic Coast Pipeline

BASIC FACTS

- ▶ 550-mile fracked-gas, high-pressure transmission and storage line
- ▶ Construction zone (clear-cut, bared earth) as wide as an 8-lane highway
- ▶ Unprecedented scale for the steep terrain in Allegheny and Blue Ridge Mountains
- ▶ Bisects the George Washington and Monongahela National Forests
- ▶ Multi-billion-dollar, long-term investment in climate-polluting fossil fuels and fracking
- ▶ Delays and displaces investment in renewable energy
- ▶ Pollutes headwaters that provide drinking water for millions
- ▶ Provides only 39 permanent jobs in Virginia, according to Dominion's own study
- ▶ 94% of route on "greenfields"—Only 6% on existing rights of way
- ▶ Industrializes the Blue Ridge—permanently fragments the biodiversity and mars the beauty and peace of a recreation and tourism mecca
- ▶ No legal or regulatory guarantee that the pipeline won't be used for export
- ▶ All property owners on the route will be forced to provide an easement (with compensation either negotiated or determined by a court)
- ▶ No practical access to gas along the route—"tap-in" fees start at 5–8 million dollars

- ▶ *A Summons from Nelson County Circuit Court for ACP, LLC*
- ▶ *A Proposal for a "cash-in-hand" easement settlement for ACP, LLC*
